Regular collections

On-demand and bulk clearances

If your business generates low volumes of confidential information, or only disposes of old records once a year, our on-demand shredding service might be better for you. As and when you need, we'll collect your sensitive materials and, if you're having a clear out, we'll provide you with as many storage containers as you need for the duration of the job.



Nationwide contracts

For multi-site organisations, we can provide you with a nationwide shredding service, where all of your confidential information, across all sites, will be looked after by one provider. For you, this means less paperwork, better communication and a clearer understanding of what happens to your sensitive materials.



Home collections

If any of your employees work remotely, you're self-employed or have personal information that you want destroyed, via our home shredding service, we can collect your confidential materials from yours and your employees' doorsteps, and transport them back to our high-security facility for shredding.

- **On-site**: Your confidential information will be destroyed on your own premises, using a shredder located on our vehicle.
- Off-site: Your confidential information will be safely transported to our high-security shredding facility and destroyed there.



Here's what we shred...

When it comes to data disposal, one of the most important things you can do is make sure your whole business is aware of what actually counts as confidential.



Without this knowledge, even with the best security measures in place, you'll still be putting your information at risk. This is why we work with our customers to help them understand the different types of confidential materials out there, and also why we shred such a wide range of materials.

We shred:



Paper documents

Whether you've got a single bag or a warehouse full, we can securely shred your confidential paper documents, giving you and your staff the time to focus on your work. There's no need to remove paper clips or staples either – we'll sort this our end.



Hard drives & media materials

If your hard drives and media materials are physically intact, even if you've deleted your files off them, there's still a chance your confidential information can be retrieved. The only way to guarantee this information remains safe is to destroy the device.



Branded uniforms, badges & clothing

If you're rebranding, you've got excess stock or top secret prototypes you need to dispose of, these must be destroyed securely. If they're not, they can end up in the wrong hands and lead to employee impersonations, identity theft and fraud.



Credit cards & bank cards

Old credit cards, bank cards and security badges might have an expiry date on them, but they still contain confidential information that can be used, even past this date. To protect yourself against identity theft and fraud, it's essential these cards and badges are securely disposed of.



Branded products

Faulty products (such as toys and cosmetics) that cannot enter the marketplace need to be destroyed. If they aren't, they're at risk of entering the black market and being sold on illegally, which can lead to reputational damage for your business.



As a standard, we shred confidential materials using the latest cross cut technology, but, for items that need more than this, we also offer high security disintegration. This reduces sensitive information down to particles 3mm or smaller in size, the equivalent of dust.

From the moment a piece of sensitive information exists to the moment it's destroyed, this information must be kept secure – and this is where storage becomes so important.


